Answers to the assignments

Assignment 1

Which books/publications related to medical treatment on board are mandatory, if you carry medicine chest A or B?

- "Inventory, Control Document and User Instructions" (A or B as relevant)
- "Medical Guide for Seafarers"
- "Radio Medical Record"
- Technical Regulations

Technical Regulations, regulation 2.2 and 2.4

Assignment 4

Any medicine or medical equipment that you cannot store together with the rest of the content?

Yes, group N (medical equipment), Insecticides and chlorinating agents, may NOT be stored within the medicine chest/along the rest of medicine/medical equipment

Technical Regulations, regulation 6.5

Assignment 2

How many different supplements exists to medicine chests A, B and C

Six different supplements:

- CR life boats and life rafts
- P Passenger
- M MOB-boats
- G Ships/risk of contact to war gas
- Dangerous goods
- F Rescue vessels from DMSA

Assignment 3

Who is responsible for correct labelling of medicine from the medicine chest?

The Captain. Find correct labels at DMA homepage/downloads

Technical Regulations (supplement), Regulation 5.1

Assignment 5

Storage and dispensing:

On board, who has permission to dispense medicine?

The Captain or The Person in charge of medical care

Technical Regulations, Regulation 10.1

May crewmembers bring their own medicine?

Yes, but they are obliged to inform the captain or the person in charge of Medical Care which/how much they bring *Technical Regulations, Regulation 6.6*

If a crewmember brings his own medicine, where should the medical officer register this medicine?

In the Inventory, and upon request, deposit together with ship's medicine

Technical Regulations, Regulation 6.7
