## GUIDELINES

This form must be used when applying for registration of a ship in the Boat Register.

If the Shipowner is not registered in the Register of Shipping/the Boat Register, an application for registration of the Shipowner must be submitted.

Proof of ownership of the ship must be enclosed in the original, for example, in the form of a builder's certificate, a ship deed, a bill of sale, a contract of sale or any other kind of documentation of the ownership (title deed).

The authority to sign for the shipyard/seller must be appropriately documented. If a ship is bought abroad, the signature must be confirmed by the Notary Public in the country concerned.

If the hull of the ship is being built at one shipyard and the ship will be completed at another shipyard, a builder's certificate must be forwarded from each shipyard.

In **field n**, previous owners must be mentioned and proof that they have been owners of the ship must be enclosed as a copy in the form of a ship deed, contract of sale or the like. If it is not possible to acquire proof, a declaration must be forwarded stating to whom he has sold the ship as well as the name and port of registry of the ship at that time. The declaration must be submitted on the form "declaration on previous ownership". Furthermore, a builder's certificate from the construction yard must be forwarded.

If the ship is imported from abroad, either a certificate of deletion or a non-registration certificate must be enclosed from the Register of Shipping of the country concerned.

A tonnage certificate must be submitted. This must have been issued by a company authorised to carry out tonnage measurement of ships by the Danish Maritime Authority. The tonnage certificate must earliest be issued 18 months before the application date for registration.
