

Deletion of digital power of attorney

Digital Ship Register (DSRG) self-service portal can be accessed using the following link: https://shipregistration.dma.dk

It is possible to create digital power of attorneys in the Digital Ship Register. By creating a digital power of attorney for a specific type of right, it becomes possible for both the appointed attorney and the principal to access a digital signing of the assignment and complete it.

The Danish Maritime Authority's website describes power of attorney in more details here: Power of attorney.

This guide explains how you can delete a digital power of attorney that you have previously created in the Digital Ship Register in the Digital Ship Register. Only the principal can delete/withdraw a power of attorney.

The following are necessary in order to make the report:

MitID to be able to log in to the Digital Ship Register Self-service

Once logged in, you will be greeted by the view below. You need to click on the "Power of attorney" icon in the menu on the left.
